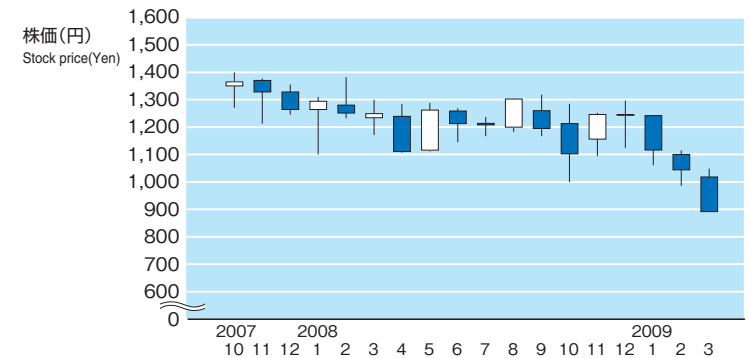

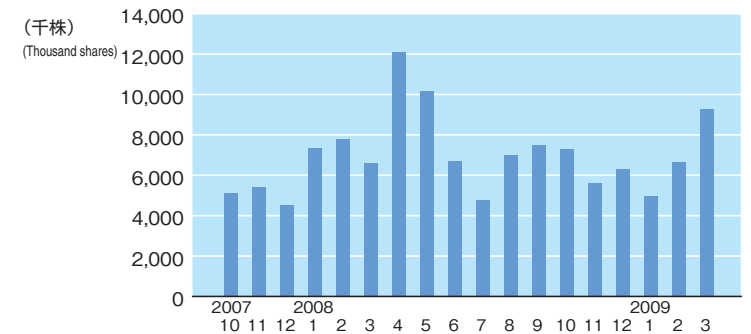

株価 Stock price trend

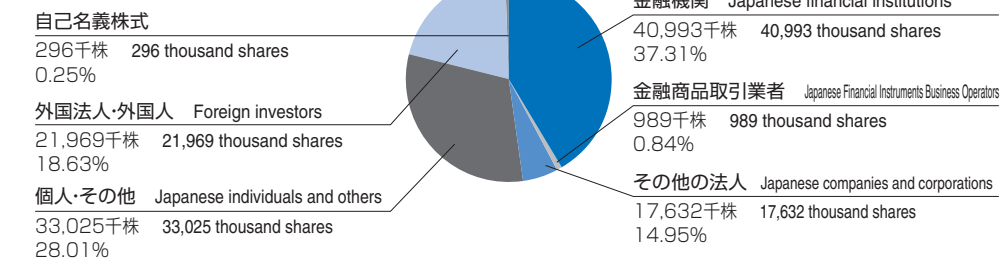


株式売買高 Trading volume

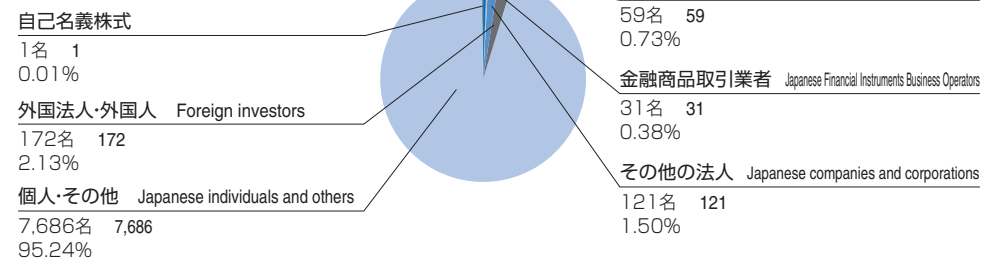


所有者別状況 Composition of Shareholders by Category
